- 1. All bills are subject to the reimbursement fee set forth on Schedule No. UF.
- 2. Pursuant to Decision 23-06-024 a surcharge of \$0.080 per Ccf will be applied to all metered customer bills excluding customers that are receiving the CAP credit. This surcharge will offset the CAP credits and CAP administrative program costs recorded in the CAP Balancing Account.
- As authorized by Rule 9.1.e. for customers with more than one meter on a single service line, the
 customer's service Charge rate is based on a factor multiplied by the service charge applicable to
 the nearest standard meter size of the Combined meters as determined by the equivalent
 diameter methodology.
- 4. Non-residential Sprinkler rates can be added as needed utilizing the multiplication factors identified in Appendix F of D. 17-03-001, applied to the 5/8" meter charge.

The surcharge recovers the difference between the interim rates and the final rates for the period of January 1, 2022 through July 30, 2023.
- 10.
