GSWC request approval from the California Public Utilities Commission (Commission) to make a correction to its approved tariff Schedule No. ME-1-NR.

Background

GSWC filed Advice Letter (AL) 1943-W with the Commission on May 21, 2024 requesting authorization to increase the water rates in its Region 2 CSA to offset purveyor rate changes for pump tax costs. The AL was approved and effective on July 1, 2024.

GSWC subsequently discovered a typo in its tariff Schedule No. ME-NR-1 for the 5/8" x 3/4" service charge submitted and approved in AL 1943-W.

Request

GSWC requests to correct the rate in tariff Schedule No. ME-NR-1 for the 5/8" x 3/4" service charge. GSWC will begin charging the corrected rate as of the effective date of this AL filing.

Effective Date

This AL is submitted with a Tier 1 designation. GSWC is requesting this AL become effective on September 9, 2024.

Notice

No individuals or utilities have requested notification of filing of tariffs. Distribution of this advice letter is being made to the attached service list in accordance with Section 4.3 of General Order No. 96-B.

Response or Protest

Anyone may submit a response or protest for this Advice Letter (AL). When submitting a response or protest, **please include the utility name and advice letter number in the subject line.**

A **response** supports the filing and may contain information that proves useful to the Commission in evaluating the AL. A **protest** objects to the AL in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

1. The utility did not properly serve or give notice of the AL;
2. The relief requested in the AL would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
3. The analysis, calculations, or data in the AL contain material error or omissions;
4. The relief requested in the AL is pending before the Commission in a formal proceeding; or
5. The relief requested in the AL requires consideration in a formal hearing, or is otherwise inappropriate for the AL process; or
6. The relief requested in the AL is unjust, unreasonable, or discriminatory, provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.

A protest may not rely on policy objections to an AL where the relief requested in the AL follows rules or directions established by statute or Commission order applicable to the utility. A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform WD, within the 20 day protest period, so that a late filed protest can be entertained. The informing document should include an estimate of the date the proposed protest might be voted on.

Replies

The utility shall reply to each protest and may reply to any response. Any reply must be received by WD within five business days after the end of the protest period, and shall be served on the same day on each person who filed the protest or response to the AL.

The actions requested in this advice letter are not now the subject of any formal filings with the California Public Utilities Commission, including a formal complaint, nor action in any court of law.
